Ari loved the job but wanted to do more. After advocating with his supervisors to be trained on more tasks, Ari learned to cook hamburgers, grill, and work as a cashier. Ari is now working a minimum of 35 hours a week at Five Guys.

The longtime South Orange resident says she is proud of her work with JESPY clients and her part in JESPY's collaboration with the Village of South Orange and nonprofit developers to build South Orange Commons, an affordable housing building for families and for adults with Intellectual and Developmental disabilities.

In addition to the Village of the Month recognition, Bugg-Levine was honored in March for Women's History Month with an Assembly Resolution at the State House in Trenton, NJ.

Assemblywoman Mila Jasey nominated and presented Bugg-Levine with the Resolution, heralding her efforts during the COVID pandemic, which included securing unemployment benefits for JESPY clients and arranging the Essex County mobile vaccination program to ensure their vaccinations.

INCLUSIVE HEALTHY COMMUNITIES PLANNING GRANT - 18 MONTHS OF STEADY PROGRESS

JESPY is now completing an 18-month Inclusive Healthy Communities planning grant, along with NJ Association of Community Partners and SRS Strategic Associates, LLC (the Project Team). The grant was funded by the NJ Department of Human Services' Division of Disability Services to support the health and wellbeing of individuals with disabilities where they live, work, learn and play.

The Project Team formed a comprehensive community coalition (which includes clients) to garner input, share findings and collaborate in order to elicit changes that could impact the health and safety of individuals with disabilities and advance inclusion at the municipal level.



JESPY clients also undertook observational assessments regarding shopping, mobility, and community accessibility for people with disabilities. A report on these findings with recommendations will soon be disseminated.
